

# **Cookie Statement**

### Visitors on our websites

Pareto Securities ("**we**" or "**us**") uses cookies, pixels and similar technologies (collectively referred to as "cookies") on our websites. This information page forms part of our Global Privacy Notice available on <u>www.paretosec.com</u>. It informs you on what cookies are, and how we use cookies on our websites and on our social media pages. This Cookie Statement applies for all our websites.

#### **Cookies**

A cookie is a small text file that a website stores on your computer or other devices when you visit the site. First party cookies are cookies set by the website you are visiting. Only the website can read them. In addition, a website might potentially use external services, which also set their own cookies, known as third-party cookies. Persistent cookies are cookies saved on your computer or other device and that are not deleted automatically when you quit your browser, unlike a session cookie, which is deleted when you quit your browser.

Pixels are image files (pixels) that trigger the use of a cookie after an event occurs. Pixels are used to connect you to third party websites.

### **Cookie Categories**

We use cookies for the basic functions of our website, such as security and network management, and to enable you to log in to your user account (necessary cookies).

We use cookies to gain insight into user interaction on our websites through anonymous recording, statistics and reporting (**analytics cookies**). This entail counting the number of visitors and distinguishing between different visitors.

We use cookies to allow us to remember your previous visits from the same device, determining the beginning and the end of a visit, indicating where (at area or country level) the visitor comes from and distinguishing between different visitors (**personalisation cookies**).

We also use cookies to provide marketing on other sites or social media platforms that we believe is relevant for you based on certain parameters, such as data about your behaviour on our site (**advertising cookies**).

#### How long are cookies saved?

How long cookies are saved on your device can vary. The time when they are are scheduled to expire is calculated from the last date you visited the website. When cookies expire, they are automatically deleted. You will find our list of cookies below.
